WELCOME / CHAIRMAN COMMENTS

APPROVAL OF Agenda

Jeff Maxon introduced a motion to approve the agenda. Steve Funk moved to approve the agenda. Ken Harmon seconded the motion. The motion passed.

APPROVAL OF MINUTES

Jeff Maxon introduced August 19, 2025, meeting minutes for discussion. Secretary Adam Proffitt moved to approve the minutes. Doug Polston seconded the motion. The motion passed.

ACTION ITEM STATUS

Sara Spinks reported there were no action items.

Executive Branch CITO Updates

Jeff Maxon reported on the following:

- The Digital Government Summit has been rescheduled to September 30 to be held at the DoubleTree Hotel in Lawrence, Kansas.
- Gartner is continuing their work on the future state and roadmap for IT integration. They are meeting with
 individual agencies to discuss feedback received from the current state assessment. Gartner will conduct a
 presentation at the October ITEC meeting.
- Andrew Eichinger was announced as the new Chief Information Technology Architect (CITA). Andrew has a
 strong consulting background, having served a lot of states specifically most recently around Health and Human
 services industry. He has a lot of time working here with the Department of Labor during COVID and is familiar
 with state governments, and will bring a lot of expertise to us in terms of what is occurring across the country.

Executive Branch CISO Updates

John Godfrey provided an update on the Kansas Plain Cyber Guardian Event, a two-week cybersecurity training from August 18-29, and includes a week of skills training followed by hands on. The exercise involves nearly 100 participants from state agencies, counties, municipalities, school districts, and the Kansas National Guard. The focus is on strengthening detection, analysis, and response to cyber threats. A distinguished visitor day on August 27 will include observers from the administration, cabinet, and legislature. The event will be held in Topeka and Wichita with plans to expand next year based on feedback.

POLICY AND PROCEDURES DISCUSSION

John Godfrey presented the introduction of Data Policies for final approval.

• Open-Source Software Management Policy was discussed and reviewed. Mike Mayta moved to approve the policy. Doug Polston seconded the motion. The motion passed. The effective date of September 1st.

Kimberly DeWitt introduced:

- The responsible use of AI guideline document aimed at fostering safe and intentional AI exploration.
- Al general policy based on executive branch policy, tailored with input from multiple state stakeholders.
- Emphasis on transparency, managing risks, and accountability in AI usage.

- Highlights include allowance for using restricted information with proper controls, training, visibility, and risk management associated with AI.
- Recognition of challenges in AI governance, such as records management, transcription of meetings, and vendor data control.
- Policy encourages training, documentation, and quality assurance akin to SDLC principles applied to AI development and usage. L
- Discussion regarding AI transcription, recording, official records, and use of AI in decision making surfaced concerns about transparency and policy gaps.
- The policy is designed to be an evolving baseline, with collaborative input and iterative updates planned.
- Participants appreciated the self-assessment toll included in the guidance for AI usage.
