Business case:

Kansas Department of Revenue Bureau of Alcoholic Beverage Control is seeking an upgrade of the internal and external presentations of the current POSSE ABC application to the newest technology presentations. A replacement of the systems that manage evidence, assign work to enforcement agents, accounting and distribution for these programs and their associated interfaces are to be included. The POSSE ABC application is utilized by internal users to enter and process applications for new licenses or permits; renew existing licenses or permits; new label registrations; revise or renew existing labels; process legal case management and track enforcement assignments. The system allows external users to apply for new licenses and permits; renew existing licenses or permits; amend existing licenses or permits; apply for new brand and label registration; renew or revise existing labels online through an electronic self-service submission process with one point of sign-on.

The system must also provide reports as specified. The system must maintain accurate financial accounting (which includes accounts receivable and distribution of fees, fines, and taxes). To achieve these goals, the State proposes to purchase a commercial off-the-shelf (COTS) software package to provide the required system integration. Through this RFP, the State seeks to buy the best services and products at the most favorable competitive prices, and to give all qualified business entities an opportunity to bid to provide the desired products and services.

The data migration from the existing system, POSSE ABC, Excel, Access, and internal KDOR web applications to the new system is required. Implementation services and systems software for the application. The system shall be hosted by the vendor with cloud backup and include all software patches and upgrades. Proposals must include post-implementation support services necessary to provide the desired solution. Only fixed price proposals will be considered.

- The newer technology will provide Kansas staff a better interface and will increase productivity and enhancements to the application. The filing of reports online will significantly reduce mail and scanning as we receive 1200 paper supplier reports monthly. This will reduce office supplies and scanning equipment use.- The enhancements to the online system will significantly reduce data entry time for Customer Representatives (CRs) for new and renewal applications.
- It will reduce the number of forms that internal staff regularly have to modify and ensure they are accessible (ADA) compliant before releasing. Incorporating the functionality of the enforcement agent assignments Liquor Licensing Database (LLDB) inside the system will eliminate the need for a second system we currently have that generates enforcement agent assignments. The current system requires a LOT of manual intervention to load the licensee information, which is also a time saving for the management systems analysts (MSAs) and KDOR IT. This will reduce the liability for inaccurate information for court records.- Entering cereal malt beverage licenses (CMB) into the system would eliminate the need for another KDOR IT system to be maintained to store the information. It further eliminates the need to manually load CMB license information into the LLDB to obtain enforcement agent assignments. Entering evidence and Undercover Cooperating Individual (UCI) information directly into the new system will streamline processes and eliminate the need to use multiple applications.- The newer technology is also easier to program and it reduces change costs.
