Email Guidelines 6401, Matt Veatch, State Historical Society

- Members of Task Force: Matt Veatch, Travis Combes, Brian Cross, Laura Graham, Ryan Leimkuehler, Lisa Mendoza, Philip Michael, Tanner Asbury, Julie Niehues, Megan Rohleder, Jennifer Scriven, Brenda Younger
- The task force is working to revise ITEC Guideline 6401 to reflect contemporary email records management best practices and to also secure the ITEC and the State Records Board approval of the updated guideline.
- Members want to ensure everyone understands the are guidelines and not a policy. However, all state and local entities in KS are encouraged to use the guidelines.

- Members want to ensure that KS state and local government email records are retained for as long as they have legal, fiscal, administrative, or historical value.
- Biggest change in 2020 is Capstone approach.
- Records retention based on an account owner's role or position rather than individual email content in the absence of more effective email management tools
- Records retention based on an account owner's role or position rather than individual email content
- Facilitates capture of permanent email records from the accounts of key policy and decision-making officials
- Federal government and several state governments using Capstone approach
- Guidelines encourage Kansas state and local government entities to consider Capstone as a way to capture permanent email records in the absence of more effective email management tools
- Matt provided a form for consideration: Capstone Email Accounts Identification Worksheet.
- The team is looking for feedback from ITAB on Email guidelines to move forward.
- Question from Adrian Guerrero: Is there a UPST filed preservation option? Matt stated there are ways to make the PST file preservable.
- DeAngela asked if the guidelines are ready to be presented at ITEC.
- Matt stated the task force is ready to present unless additional feedback from ITAB body requires additional conversation.
- Deadline for feedback is February 29th.
- If no additional feedback, the guidelines will be presented at the next ITEC meeting.

2000 Series, Project Management Sara Spinks, KITO Director

- Sara Spinks and team have presented to ITAB, ITEC & JCIT where they have received positive responses
- Projected to roll out July 2021
- The system is not ready to be tested yet.
- The team is looking for testers. If you have anyone that would be willing to assist the team with the process and is willing to test, it would be beneficial to get more feedback, especially from small agencies.
- DeAngela stated that participation is key for this to be successful. Very inclusive.
- JCIT is keen on risk management. They do not want to be a bottleneck or troublesome, they want to be more responsive and provide oversight. They recognize the need for more oversight for projects, which instigated SB57
- This updated policy is a first step to get where we need to be.
- Let Sara know if you have interest in participating on her team.

- Duncan Friend asked that a future item of discussion be a review of the accessibility of IT.
- Colonel Stinson: Would like to receive a copy of the cyber security legislation. DeAngela stated that we will circulate the legislation again. The legislation included minor changes.
